

## Summer Road to Savings Sweepstakes

### Official Rules

May 12, 2022 – September 14, 2022

- 1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**
- 2. PURCHASE DOES NOT IMPROVE AN INDIVIDUAL'S CHANCES OF WINNING.**
- Each Sweepstakes entry will have an equal chance of winning. Odds of winning will depend on the number of entries received.
- 4. Prizes:** (25) \$100 Chevron gift cards will be awarded to (25) eligible winners from all entries received before the end of the sweepstakes period.

The value of the prize is \$100.

No prize substitution allowed.

- 6. Sweepstakes Period:** Sweepstakes begins May 12, 2022, and ends September 14, 2022. All qualifying entries and alternate entries must be completed and received by 11:59 PM on September 14, 2022.
- 7. Eligibility:** The Sweepstakes is open to SchoolsFirst FCU Members, and non-members who are eligible for Membership. By entering this sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of the Credit Union. Sweepstakes void where prohibited by law. Members of SchoolsFirst FCU's Official Family (teammembers, officials and volunteers) and members of their immediate families are not eligible to participate in the Sweepstakes. Anyone not complying with the Official Rules will be disqualified and is not eligible to win a prize.
- 8. How to Enter:** Entries can be made in the following ways. Members who buy a car through Autoland or Enterprise Car Sales and finance their auto loan with SchoolsFirst FCU from May 12, 2022 – September 14, 2022, will be automatically entered into the sweepstakes. An alternate entry may be made by a SchoolsFirst FCU Member by printing their full name, address, and telephone number on a 3" x 5" card and mailing the card in a sealed envelope to: SchoolsFirst FCU, Attention: Summer Road to Savings Sweepstakes, PO Box 11547, Santa Ana, CA 92711-1547. Limit one alternate entry per person. No copies, mechanical reproductions, or metered mail accepted. The Credit Union is not responsible for lost, late, incomplete, misdirected, damaged, postage-due, or illegible entries. Once submitted, entries become the sole property of the Credit Union and will not be acknowledged or returned. The maximum entries per eligible entrant is one by all methods combined.
- 9. Drawings and Notification:** Five winning entries will be selected the weeks of June 13, 2022; July 11, 2022; August 8, 2022; September 12, 2022; and October 10, 2022 from all entries received. Winners need not be present to win, and will be notified by secure message through Mobile and Online Banking, phone or mail with details on how to claim their prize. If a sweepstakes entry is drawn, but judges are unable to determine the winner because of inaccurate or illegible information, that entry will be disqualified. If a winner cannot be contacted or fails to sign the Prize Acceptance Agreement form within 30 days of notice, the winner forfeits the prize. In the event a winner forfeits the prize, an alternative winner will be selected from among all remaining eligible entries. Winners must sign a Prize Acceptance Form to receive the prize. Anyone not complying with the Official Rules will be disqualified and is not eligible to win a prize.

10. **Publicity:** By entering the sweepstakes, signing a Prize Acceptance Form and accepting the prize, winners grant SchoolsFirst FCU the right to use the winners' name, photograph or likeness in any and all forms of media for use by SchoolsFirst FCU for any reason, and waives any right to inspect or review any materials or receive compensation.
11. **Liability:** Entrant agrees to hold the Credit Union and its officers, directors, employees and representatives harmless from any liability arising from the participation in the Sweepstakes or the acceptance, receipt, possession, or use/misuse of the prize.
12. **Taxes: The Credit Union will report all prize winnings to the appropriate state and federal agencies as required by law. Winner is responsible for all tax consequences (if any) of the prize.**
13. **Arbitration:** Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that any and all disputes and causes of action arising out of or connected with this Sweepstakes, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association (AAA) and held at the AAA regional office nearest the sponsor. Judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorney's fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with entering Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
14. **Choice of Law:** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and the Credit Union in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the State of California, USA, without regard to choice of law rule.
